Chapter 7 A Debate (Dialogue) between Christ and the Pharisees.

Once a debate occurred between Christ and the Jew Pharisees. The Pharisees argued that Christ exorcises evil spirits from people affected by evil spirits with the help of Bee-el-ze-bub, the prince of devils. Christ asked a question in return. "By whom your children cast them out?"

"By whom Christ cast out evil spirits?" The answer to this question was their wrong argument found by themselves. [Their argument was that Christ doing exorcism by the help of Bee-el-ze-bub, the Prince of devils]. So Christ asks them in return "By whom your children cast them out?"

They had to keep quiet before this counter question of Christ. He teaches them that it is being done by the help of the Holy Spirit and censure them for their baseless accusations. He clarified the point to the Pharisees that exorcism can only be done by the power of God.

From the question of Christ, we can realize that the children of Pharisees used to cast the devils from people possessing with evil spirits.

"By whom your children cast them out?" Let us try to find the answer to this question of Christ to the Pharisees. In Bible, we can not see any answer given by the Pharisees.

A good book is there among the Jews which describes the remedies and various methods for doing exorcism, written by the great scholar, King Solomon. The children of Jew Pharisees used to cast out evil spirits and cure people with the help of these remedies written in that book. Christ reminds the truth that the children of Pharisees expel the devils through executing divine activities and invocations by his counter question. Christ doesn't accuse or deny such activities of the children of Pharisees. He only approves the divine activities. He was reminding the Pharisees that the power of Holy Spirit is acting while exorcism.

The job of the Pharisees was teaching law (Thora) in synagogues. The children of Pharisees made a living by executing the methods described in the Book of Hymns written by the great scholar King Solomon. God's another set of people the Muslims (successors of 'Ismael'son of Abraham) treated as brothers of Jews, also cast out evils using King Solomon's book. Since Christians do not commit circumcision, they don't have the right or permission to do exorcism using the methods written in King Solomon's book. If anybody who didn't commit circumcision try to practice exorcism using the above book, then he will face major counter attack from the devil's part.

When a person thinking of his current problems and problems he had faced in the past, Astrology is cent percent useful to check whether the attack of evil spirits or embedment be the cause of those problems. Horary Astrology is useful for easily finding out whether a person carries evil spirits or not.

When somebody approaches an astrologist with his problems, then the astrologist with the help of Horary Astrology, finds the root cause of the problems and suggest the remedies for it.

"I will destroy your witchcraft and you will no longer cast spells". (Micah 5:12)

From the above words in Bible, we can realize very clearly that black magic is a reality and for recognizing it, horary astrology is useful.

The Jews use Aramic astrology and Muslims use Arabic astrology. (both are same, differ only in language). The astrology made use of by Jews and Muslims was written by the top most scholar King Solomon.

According to Hindus, there exists the astrology revealed to the ancient scholar Rishis by God and burnt offering is used for expelling the evil spirits. In principle, Arabic astrology, Aramic astrology and Indian astrology are one and the same.

Even though Christ and his disciples had undergone circumcision, the Christians have to lead a life denying circumcision and therefore the Aramic astrology and Arabic astrology became strange to them. Because the divine knowledge being given by God to King Solomon is the privilege only to those commit circumcision.

When we think of "Black Magic", there are 3 categories of people who utilizing astrology.

First section of people: Use astrology to check whether they have been troubling as a result of evil spirits embedded due to black magic done by the foes.

Second section of people: The righteous priests like children of Pharisees, Muslim righteous priests and Hindu clergymen check the success of their divine activity and invocations for exorcism.

Third section of people: check the percentage of success of the black magic done by them secretly to embed devils into a person. The person who does this thing is called a sorcerer.

Did you get the idea that astrology is an ancient and divine knowledge(science) and it can be used for both good and bad things by man.

We shouldn't have the misunderstanding that astrology is a complex science only related to black magic. We can co-relate each and every matter occurs in our day-to-day life with astrology. That is why the scope of astrology is said to be infinite.

In this context, the holy words of Christ is memorable here.

"Do not think that I have come to do away with the law of Moses and the teaching of the prophets. But to make their teachings true. Remember that as long as the heaven and the earth last, not the least point nor the smallest detail of the Law will be away with – not until the end of all things. So then whoever disobeys even the least important of the commandments and teaches others to do the same will be least in the kingdom of heaven." Mathew 5.17-19

Christ points out the importance of circumcision, indicating that it had been given through Abraham. We can think of Christ's sermon that he had come not for removing laws and prophets, but to fulfill them. But in the message to Galatians, St. Paul writes,

"Mark my words! I Paul, tell you that if you let yourselves be circumcised, Christ will be of no value to you at all".(Galatians 5:2)

For this reason, it is clear from Christ's words that St. Paul will be one among the inferiors in heaven. Because he is against circumcision. Here St. Paul clashes with the divine advice of the Chief Master Christ.

In Bible, we read that St. Paul felt in his spiritual vision that he was carried up to the 3rd level of heaven. This will make wonder those who don't have a proper idea about the structure of heaven. They will create an idea that St. Paul is a superior in heaven.

Speaking about heaven, it is widely spread seven worlds or domains situated one upon the other. Each world has its own sky and astral stars and moons. The star indicating the holy birth of Christ, rose on the eastern horizon was such an astral star.

Even though these seven heavenly worlds situated one on the other, they arranged in such a way that they are not face to face or visible to each other. The topmost 7th world is called "Sathyalokam"(True Heavenly World). Here exists the God(Brahmavu), his son of min d(Christ/Prajapathi), numerous messengers of God, and the children of the mind of Christ, viz Shiva, Vishnu and the righteous Goddesses.

All these 7 heavenly worlds together called Heaven. The most excellent and noblest one is the 7th heavenly world called "Sathyalokam". From these right description, we can understand that St. Paul is not a superior in heaven. Because he was brought only to the 3rd heavenly world in his vision.

Acts 7.7-8, we read that St. Stephen loudly declares the everlasting agreement circumcision between God and Abraham. From the consecutive portions, we realize that the spirit of that brave martyr was taken to the 7th heavenly world ("Satyalokam" according to Hindu Doctrines) where Christ exists.

According to Hindu doctrines, the concept of heaven is 7 heavenly worlds. According to Jew-Muslim opinion, the seven heavenly worlds are called "the Seven Paradises".

The 'Eden Garden' created by God to protect the first man was also known as paradise. But the seven heavenly worlds or "Seven Paradises", situated far away beyond the concept of man, from earth.

Come to the matter we were discussing. The Jews and the Muslims doing exorcism by the help of the divine knowledge given to King Solomon by God. But Christians could not do this as they don't commit circumcision. That is why the Christian Priests retreat by saying involuntarily the "untruth" that there are no devils. The Christians should have the opinion that the privilege to acquire the divine knowledge given to king Solomon by God is not only confined to the Jews and Muslims, but also to the Christians. If that happens, then the Christians will synchronize with Christ, who himself committed circumcision, by being obedient to the rules like circumcision. In that era, all the Christian denominations will unite together and one shepherd and one sheep-pen will be there. Shepherd means Christ and sheep-pen means Christian religion. But from another chapter, we can understand that this happens only after that God's Great day of Wrath.

The Christians to whom the divine knowledge (Aramic astrology and hymn) is denied or forbidden due to the reason that they don't commit circumcision, were split up into hundreds of pieces. They can not ever approve each other and they kept rivalry towards each other. One section contempt other side as "devils". The secret of the unified advance of the Muslims and the Jews, who undergo circumcision, without any thinking of disintegration (fragmentation) after the expiry of hundreds of years is very clear. Since they follow the law of circumcision, which is pure and everlasting and given by God, they can retain their divine knowledge as their privilege and this itself is the inherited tendency to remain them as (Jews and Muslims) societies without having any thinking of disintegration.

The Hindus in the wide subcontinent of India, are strongly bound by the ancient knowledge of astrology and hymn. "Only the twelve tribes of the Israel community are obliged to commit circumcision. But Christians are not bound to do it" this is a common argument by most Christians.

We can see expatiations regarding the Holy Jerusalem Temple made for eternity in Ezekiel 44:9. "I, the Sovereign Lord, declare that no uncircumcised foreigner, no one who disobeys me, will enter the temple, not even a foreigner, who lives among the people of Israel"

Here we see that Christians are prohibited from entering into it. This is a strong blow and counter attack to those who agree that everyone should join Christian religion for salvation.

Since no Christian is eligible for stepping into the holy Temple of God in Jerusalem which is made for ever, it is clear that there is no Christian community exists in this world according to the wish and desire of the Christ.

In this context, I am thinking of a scholar's words" the first and last Christian died in the cross." His supposition of the first Christian is Christ himself who respected all the divine laws including the circumcision. He figures Christ as the last Christian as he knows the fact that nobody ever seen in Christian religion who followed all the said divine laws of God.

Luke 2:21, we read that Christ had undergone circumcision on 8th day of his holy birth. Did you get that how far the Christians from Christ?.
